While VisaCenter ensures that information is made available to the visa applicant promptly and accurately, the Visa Applicant shall at all times be responsible for providing and maintaining an SMS text compatible mobile phone number where VisaCenter can send text messages regarding the status of the Visa Application to the Visa Applicant. The Visa Applicant is responsible for ensuring connection to a mobile network capable of receiving the SMS Services. The Visa Applicant understands that if The Visa Applicant 's mobile phone is switched off, disconnected for any reasons or is out of coverage for a period of 24 hours or more, The Visa Applicant's mobile network provider may delete any SMS messages to be received by The Visa Applicant.

2. REGISTRATION WITH US EMBASSIES

The world unfortunately is not a safe place. When you travel abroad and surrounded by foreign environment many situations, in some cases hostile may arise, like terrorist attacks, banditry or even war. Plus there are natural disasters and catastrophes.

Visacenter.us can help you to make your contact information in the country where you are traveling available to US Embassy/Consular officials responsible for helping Americans abroad.

What is the registration?

Upon your request the Department of State in Washington DC will be provided with your major contact information in the country of your travel. In the event there is a need to contact Americans to offer urgent advice or evacuation during a natural disaster or civil unrest, US Embassy/Consulate contacts all registered US citizens in that country. U.S. consular officers assist Americans who encounter serious legal, medical, or financial difficulties.

OFFICIAL REGISTRATION IS RECOMMENDED for **ALL Americans** traveling abroad for business or pleasure, or residing abroad, irrespectively of the length of travel.

It is best to register **BEFORE the start of the trip.**

To register, you are required to fill-out short US Embassy Registartion Request Form with your basic contact and travel information.

Nigeria Visa Requirements

- Original, signed United States passport with at least 6 months of remaining validity.
- Two passport type photos (photos can be taken at our Washington and New York offices).
- Filled out and signed Nigeria visa application form. Application forms must be filled out online at https://www.immigration.gov.ng/.
 Important Note: hand filled out forms are not accentable and application get rejected!

Important Note: hand filled out forms are not acceptable and application got rejected! - Filled out and signed <u>Visa Center Order form</u>.

- Itinerary. Copy of round trip tickets or itinerary. Hotel Reservations. Copy of confirmed hotel reservations.
- Bank statement. Copy of the applicant's most recent monthly bank statement. The statement must clearly show the applicant's name as the account holder, the balances of the accounts, and the date of the statement.
- Private visa: Letter of invitation from host accepting full immigration responsibility and data page of host passport.
- Previous visa. If applying for a multiple entry visa, please provide a copy of a previous Nigeria visa. The embassy will not grant a multiple entry visa to a first-time visitor.
- Persons with dual citizenship, one of which is US, must apply with their US passports only. Applicants with other than US passports must provide the copy of the document confirming their current resident status in USA
- Note: Nigerian embassy has special payment procedure. Part of the consular fees must be paid on-line here: https://www.immigration.gov.ng/. And for this the credit card of the applicant (with applicant's name on it) will be used. The amount of this on-line fee is \$180.00 (for US passport holders applicants) and it is NOT included in the price above.Printed out confirmation of payment is required.

- Letter of invitation from Host Company, in Nigeria, accepting full immigration and financial responsibility as well as stating purpose of visit (and duration of stay).
- Letter of introduction from Applicant's company or organization

- D. Visitors must have a contact address, a letter of invitation, copies of 1st five pages of host's passport, a passport photograph, and a valid passport to accompany application form.
