REGISTRATION WITH US EMBASSIES

VISA REQUIREMENTS FOR THE REPUBLIC OF PARAGUAY

A) EACH APPLICANT (INCLUDING CANADIANS) MUST PRESENT:

- 1. Two signed Visa Application forms fully completed (forms may be obtained from the Embassy).
- 2. Passport (signed & valid for at least 6 months from application date). Please also <u>submit 2 copies</u> of both pages and 3 in addition to the original passport.
- 3. Two recent passport size photographs.
- 4. Two copies of the air ticket to Paraguay (round trip) or official letter from the travel agency **per applicant**.
- 5. Proof of economic good standing (one <u>original and one copy</u> of a bank letter and/or last bank statement. A company letter is required in case of a business trip). Each applicant must present separately.
- 6. Documents may be presented to the Embassy in person or by courier only. In the last case, a pre-paid courier return envelope with its own account # must be included. Do not use mail.
- 7. At least five (5) working days are required for processing.
- 8. Money order or cheque. (45 US for single Entry 65 US for multiple entries).
