The Visa Applicant is responsible for ensuring connection to a mobile network capable of receiving the SMS Services. The Visa Applicant understands that if The Visa Applicant 's mobile phone is switched off, disconnected for any reasons or is out of coverage for a period of 24 hours or more, The Visa Applicant's mobile network provider may delete any SMS messages to be received by The Visa
- 2. REGISTRATION WITH US EMBASSIES

The world unfortunately is not a safe place. When you travel abroad and surrounded by foreign environment many situations, in some cases hostile may arise, like terrorist attacks, banditry or even war. Plus there are natural disasters and catastrophes.

Visacenter.us can help you to make your contact information in the country where you are traveling available to US Embassy/Consular officials responsible for helping Americans abroad.

What is the registration?

Upon your request the Department of State in Washington DC will be provided with your major contact information in the country of your travel. In the event there is a need to contact Americans to offer urgent advice or evacuation during a natural disaster or civil unrest, US Embassy/Consulate contacts all registered US citizens in that country. U.S. consular officers assist Americans who encounter serious legal, medical, or financial difficulties.

OFFICIAL REGISTRATION IS RECOMMENDED for **ALL Americans** traveling abroad for business or pleasure, or residing abroad, irrespectively of the length of travel.

It is best to register **BEFORE** the start of the trip.

To register, you are required to fill-out short US Embassy Registartion Request Form with your basic contact and travel information.

• NOTE: US, EU and Canadian passport holders do not need to apply for UAE visas in advance and may get it upon arrival.


Valid color copy of the main page of your passport (valid at least for 6 months from departure date & min. 2 empty pages). Any passport page MUST NOT contain any ISRAELI stamps or marks.

<u>Important note</u>: Holders of Canadian or other country Travel Documents, Afghanistan, Bangladesh, Iraq, Liberia, Libya, Mali, Somalia, Ghana, Syria and Yemen passports need not to apply as UAE is not issuing visas for them. Applicants with <u>Iranian passports</u> should expect their visas to be processed not earlier than 7 days.

- One recent passport size color photo against white background.
- Flight details (itinerary) indicating the date of arrival to UAE as well as arrival airport (when applying for 14 days stay visa)
- Note:
 - E-Visas are accepted for processing by UAE authorities not earlier than 15 days before entry. You may send us your application earlier, but actual processing will start NOT earlier than 15 days before actual entry date into the UAE as indicated on flight details (itinerary) print-out.
 - E-Visas are valid for entry and exit UAE via airport only. Those who plan to enter/exit by land or by sea (cruise passengers) must apply for land visa only.
- Applicants WITH other THAN US passports must provide the copy of the document confirming their current resident STATUS IN US (PR Card, WORK Permit, Study Permit)
- Note:
 - All female travelers younger than 24 years old must be accompanied by parent(s).
